Preface

Welcome to the *MaSTR User's Manual*. The purpose of the *MaSTR User's Manual* is to answer your questions and guide you through the procedures necessary to use the MaSTR application efficiently and effectively.

Using the manual

You will find the *MaSTR User's Manual* easy to use. You can simply look up the topic that you need in the table of contents or the index. Later, in this Preface, you will find a brief discussion of each chapter to further assist you in locating the information that you need.

Special information about the manual

The *MaSTR User's Manual* has a dual purpose design. It can be distributed electronically and then printed on an as-needed basis, or it can be viewed online in its fully interactive capacity. If you print the document, for best results, it is recommended that you print it on a duplex printer; however, single-sided printing will also work. If you view the document online, a standard set of bookmarks appears in a frame on the left side of the document window for navigation through the document. For better viewing, decrease the size of the bookmark frame and use the magnification box to increase the magnification of the document to your viewing preference.

Conventions used in the manual

The MaSTR User's Manual uses the following conventions:

- Information that can vary in a command—variable information—is indicated by
 alphanumeric characters enclosed in angle brackets; for example, <Model Name>. Do not
 type the angle brackets when you specify the variable information.
- A new term, or term that must be emphasized for clarity of procedures, is italicized.
- Page numbering is "online friendly." Pages are numbered from 1 to x, *starting with the cover* and ending on the last page of the index.



Although numbering begins on the cover page, this number is not visible on the cover page or front matter pages. Page numbers are visible beginning with the first page of the table of contents.

- This manual is intended for both print and online viewing.
 - If information appears in blue, it is a hyperlink. Table of Contents and Index entries are also hyperlinks. Click the hyperlink to advance to the referenced information.

- Appendix C, "MaSTR Validation Study," on page 133 provides a high-level overview and the conclusions that were reached by the preliminary validation of MaSTR, which indicated that MaSTR provides the rigor of a fully continuous probabilistic approach for evaluating genotypes in mixtures in a straight forward software program.

Chapter 1 Getting Started with MaSTR

MaSTR Software Architecture

Figure 1-1 below shows the MaSTR software architecture. MaSTR consists of three primary components: a database, an API server, and a client. The database and the API server are contained within a virtual machine (VM) image, which means that the CPU for the computer that is running the VM must be enabled for VM support.







Table 1-1: MaSTR software architecture components

Component	Description						
Database - Mongo database. Manages the job queues, stores required critical supporting information for analysis jobs such as panels, models protocol sets, and so on, and stores analysis job results.							
2	API Server - Runs the analysis and communicates with the client to provide analysis results. The server must be running before a client can connect and run an analysis. See "The API server" on page 16.						
The database and API server are packaged together in a virtual machine (VM) that is run on a central computer.							
3	Client - One or more clients can connect to the central computer to submit jo to the API server and review results. See "The MaSTR client" on page 16.						

The API server

The API server must be running before a client can connect and run an analysis. SoftGenetics provides the required open virtual appliance (.ova) file that describes the VM. You can use Oracle VirtualBox or any compatible virtualization program that allows you to create and provision VMs on desktop devices running an x86-based platform to import the .ova file. After you launch the server VM, a login window opens, but you do not need to log in to the server. Within a few seconds of the login window opening, the server is accessible to all the connected clients. By default, the 8000 port on the server is forwarded to the 8000 port on the computer that is hosting the server VM and this is the only port that must be exposed; however, if necessary, you can adjust the port forwarding settings in the virtualization program to expose a different port. Also, after the server machine is launched, if possible, you should increase the amount of RAM that is provided to the VM and you should also increase the number of virtual CPU processors. The MaSTR client

You access the MaSTR client through a web browser, with Google Chrome being the preferred browser. The client accesses the server at port 8000 for the computer that is running the virtual machine, or whichever port is exposed from the virtual machine. If the client and server are running on the same computer, and port 8000 is the exposed port, then the location is https://localhost:8000. To trust the server's certificate, which encrypts the traffic between the client and the server, you must allow an exception. After a user logs in, a session is created.



To learn how to use the client, you should log in under "Demo" mode (no username and password are required), and then take the guided tour through the software. See "Starting the MaSTR Server and Logging in to MaSTR" on page 20.

Installing MaSTR

The MaSTR server is provided as a virtual machine (VM) image file, which is referred to as an open virtual appliance (.ova) file. To install the MaSTR server, you must have a virtualization program such as VMWare or Oracle VirtualBox available on the machine that is hosting the virtual server, and you must import the SoftGenetics-supplied .ova file that describes the VM.



The following instructions are based on using Oracle Virtualbox and are provided here for example purposes only. You can use any compatible virtualization program that allows you to create and provision VMs on a desktop device that is running an x86-based platform.

To install MaSTR

1. Download and install Oracle Virtualbox: https://www.virtualbox.org/wiki/Downloads.



Make sure to select the correct host type (the OS of the computer that is running the VM).

- 2. Download and install the Oracle VM VirtualBox Extension pack.
- 3. Open VirtualBox.
- 4. On the main menu, click File > Import Appliance, and then browse to and select the .ova file that SoftGenetics supplied to you.
- 5. Click Next, and then click Import.

An entry for the MaSTR server is displayed in the left pane of the VirtualBox Manager main window. The server is powered Off.

- 6. Select the MaSTR server image, and on the main menu, click Settings.
 - The Settings dialog box opens.
- 7. In the left pane of the Settings dialog box, click System.
 - The right pane of the Settings dialog box displays the VM settings that can be adjusted. The Motherboard tab is the open tab.
- 8. If possible, on the provided scale, increase the largest amount of RAM that is provided to the VM. Do not adjust the value past the green zone.

9. Open the Processor tab, and then on the provided scale, adjust the number of virtual CPU processors to highest possible value that remains within the green zone.

- 10. Close the Settings dialog box.
 - The VirtualBox Manager main window remains open.
- 11. Continue to "Starting the MaSTR Server and Logging in to MaSTR" on page 20.

Starting the MaSTR Server and Logging in to MaSTR

After you install MaSTR, you must power on the server VM. After you power on the server VM, you can log in and use MaSTR. You can use either Google Chrome or Mozilla Firefox to log in to MaSTR; however, Google Chrome is the preferred browser. When you log in to MaSTR, you must select a login mode, and then with the exception of the Demo mode, enter a username and password. Four login modes are available:

Table 1-4: MaSTR Login modes

Mode	Description
Admin	Provides access to the MaSTR administrator UI, including user management. See Chapter A, "MaSTR Administration," on page 97.
Demo	Provides unrestricted access to a temporary database and guides you through the use of the software. Designed to help analysts understand and develop skills in the principles of routine mixture analysis. A username and password are not required.
Casework	Access to a permanent database that is to be used for routine application of validated models to casework samples.
Research/Validation	Access to a permanent database that is to be used for validation of existing models and development and testing of new models.



If you log in to MaSTR under any mode other than Admin, then when the MaSTR Login page opens, it displays the total number of licenses in use and the total number of licenses that are available. (If you log in under the Admin mode, then your login does not count against the total number licenses in use.) If all available licenses are in use, then you cannot

log in until at least one other user logs out.

To start and log in to MaSTR




The following procedure is a quick overview of starting and logging in to MaSTR using one of the MaSTR default user accounts. For a detailed discussion about the different MaSTR user accounts and managing these accounts, see Appendix A, "MaSTR Administration," on page 97.

- 1. Open Oracle VM VirtualBox.
- 2. In the left panel of the VirtualBox Manager main window, make sure that the MaSTR server image is selected, and then on the main menu, click Start.

After the MaSTR server VM is successfully turned on, "Powered On" is displayed on the server image and a login window opens.

3. Open a browser window. (Google Chrome is the preferred browser.)



The following step assumes that the exposed port is the default port of 8000. If your MaSTR administrator has exposed a different port to the MaSTR server, for example, 8080, then enter the value for this port instead.

- 4. In the Address field, enter the correct URL:
 - For local access to the MaSTR server, enter https://localhost:8000/.
 - For remote access to the MaSTR server, enter https://<server address>:8000/, where the server address is either the IP address or the fully qualified domain name (FQDN) for the MaSTR server.

The MaSTR Login dialog box opens. See Figure 1-6 on page 21.

- 5. On the Login page, select the correct login Mode, for example, Research/Validation.
- 6. Do one of the following:
 - For Demo mode, click Login.
 - For any Mode other than Demo, enter your username and password, and then click Login.

For any mode other than Admin, the MaSTR software application opens in the Analysis view, which is the default view. The two other available views are Models and System. For the Admin mode, the Admin view opens.



After you log in to MaSTR, your login is active for eight hours. After your login expires, you are redirected to the MaSTR login page; however, none of your queued jobs or jobs that are already running on the server are affected.

- 7. Do one of the following:
 - If you logged in under Admin mode, then continue to Appendix A, "MaSTR Administration," on page 97.
 - If you logged in under any other mode other than Admin, then open the appropriate view and continue with your work in MaSTR.

Logging out of MaSTR

After you log in to MaSTR, a main menu icon (the Hamburger icon, indicated as Item #1 in Figure 1-8 below) is displayed in the upper left corner of the MaSTR title bar. You can click this open to open the MaSTR main menu, which contains a Logout option. Click Logout to immediately close and log out of MaSTR. When you log out of MaSTR, any unsaved work is lost; however, none of your queued jobs or jobs that are already running on the server are affected.

Chapter 2 MaSTR Primary Views

MaSTR Profile Files and Signal Files

Two types of files—a *Profile* file and a *Signal* file—are required in various functional areas (views) of MaSTR for setting up an analysis job and carrying out the job. Both file types have the following features in common:

- Both file types are tab-delimited text files that have a single header line and one row per marker.
- Both file types can include a sample name in each row of data with the following caveats:
 - If the file is for a single individual, then the Sample Name field is optional, and if you do not specify a name, then MaSTR automatically generates the name for the individual based on the file name. See Figure 2-1 and Figure 2-2 below.




Figure 2-3: Sample file with multiple sample names

 - If the file stores the information for multiple individuals, then you must give each individual a unique name. See Figure 2-3 on page 28.

Profile files

A *profile* file, also referred to as a *genotype* file, lists the alleles for specific individuals at the loci that are being tested. Optionally, a profile file can also include the signal (peak) height for each allele.

In MaSTR, there are five profile types to consider:

- Reference The profile that the job is analyzing. A Reference Profile file can contain only a single profile.
- Known A profile that is assumed to be in the mixture that is being analyzed. A Known Profile file can contain only a single profile.
- Alternate An alternate profile is calculated as if it were the reference profile. An
 Alternate Profile file is useful when there is a chance that a different individual might
 have contributed to the mixture that is being analyzed. An alternate profile is also useful
 when determining the LRs (Likelihood Ratios) for known mixtures. An Alternate Profile
 file can contain only a single profile.



Collectively, Reference, Known, and Alternate Profile types are referred to as Analysis Profile types. If you load an Analysis Profile file that contains more than one sample name for a job, then MaSTR loads only the data from the first sample.

- Elimination The profile for a laboratory individual or other individual whose DNA could
 potentially contaminate a sample. Elimination profiles are stored in the MaSTR
 Elimination database. MaSTR uses elimination profiles to calculate Likelihood Ratios
 against the mixture that is being analyzed and reports them if their results exceed set
 thresholds. An Elimination Profile file can contain a single profile, or it can contain
 multiple profiles.
- Protocol Set Also referred to as the System profile. The profile that is required for establishing the parameters for a lab-specific analysis protocol, or standard operating procedure (SOP). A System profile requires multiple profiles in a single file.

Signal file

A signal file lists the alleles for specific individuals at the loci that are being tested and the signal (peak) height for each allele. A signal file must contain at least one non-OB allele for each marker where OB is a flag that indicates "out of bounds."

MaSTR View Common Navigation Tools

If you log in to MaSTR under any mode other than Admin, then the application opens in the Analysis view, which is the default view, and is referred to as a *primary* view. The two other primary views that are available are Models and System. The Analysis View has a single tab - the Analysis Jobs tab. The Models view and the System view have multiple tabs.

If you log in to MaSTR under the Admin mode, then the application opens in the Audit view, which is the default view, and is referred to as a *secondary* view. The other secondary views that are always available are Sessions, User Management, Settings. If you log in as root under the Admin mode, then another secondary view, the Database view, is also available.

Regardless of the mode that you are logged in under, and the view and tab that are open, the following navigation tools remain the same.




Figure 2-6: MaSTR application views, common navigation tools

Main menu

You click the main menu icon (the Hamburger icon) in MaSTR to open the MaSTR main menu. At the top of the main menu, a Welcome message is displayed, along with the username (the name that you used to log in to MaSTR). After the Welcome message, regardless of the view, the same menu options are displayed from top to bottom. See Table 2-2 on page 32.



Number of rows displayed per page feature

When some view tabs first open, by default, they display 10 rows per page. For example, when the Analysis Jobs tab opens, it displays the ten most recent analysis jobs that are queued on the server, currently running on the server, or have finished running on the server in reverse chronological order. You can use the Previous and Next features at the bottom of each page to scroll through all the analysis jobs that have ever been carried out on the server. To change the number of rows that are displayed per page, select a different value on the Rows per page dropdown list.

Filter feature

On some view tabs, a Filter feature is displayed. You can use the Filter feature to reduce the number of items that are displayed on a tab and exclude those items that do not match specific filtering criteria.

Figure 2-8: Filter feature




For example, when the Analysis Jobs tab opens, it displays the ten most recent analysis jobs that are queued on the server, currently running on the server, or have finished running on the server in reverse chronological order. To filter the display on a tab, click in the Filter field, enter the filter criteria, and then press Enter. Any items (in this example, any analysis jobs) that do not match the filter criteria are excluded from the display and the tab display is updated accordingly. The filtering is based on the exact order of the characters in the filter string, but the string is not case-sensitive and it can appear anywhere in the search results. The filtering might or might not be carried out against all columns on the page. For example, if you enter **Test** as the filter criteria on the Analysis Jobs tab, then the filtering is carried out against the User column, the Name column and the Reference column. Any jobs that do *not* have this string in at least one of these columns are excluded from the display. (Only those jobs that have this string in at least one of these columns (in this example, the Name column), such as **test**1 or **Blank**Test, *are* displayed on the tab. To have all items displayed again on a tab, you can click the Clear Field icon (the "x") in the Filter field, or you can clear the Filter field (make sure that the field is blank), and then press Enter.

Sort feature

On some view tabs, you can sort the default display on the tab by any characteristic or property (column) of the items on the tab. If sorting is possible on the tab, then when the tab opens, a Sort Order icon (an up or down arrow), is displayed next to the default sorting property.

For example, when the Analysis Jobs tab opens, it displays the ten most recent analysis jobs that are queued on the server, currently running on the server, or have finished running on the server in reverse chronological order and a reverse Order Icon is displayed next to the Queue time column. To sort the job display on the tab by User, click the User column header. An ascending Sort Order icon is displayed next to the User column header. To reset the sort order, click the User column header again. A descending Sort Order icon is now displayed next to the User column header.



The Sort feature is not persistent. If you change the sort order of the display on a tab, exit the tab, and then return to the tab, the sort order is returned to its default order.

Dropdown list filter feature and total number of items in database





Figure 2-10: Dropdown dynamic list feature

Some view tabs display the items that are available in the MaSTR database in a dropdown list. The total number of these items that are available in the MaSTR database is displayed in parentheses after the tab name. For example, on the Panels tab, all the panels that are available in the database for your MaSTR installation are displayed on the Panels dropdown list and the total number of panels that are available in the MaSTR database is displayed in parenthesis after the tab name. When a tab that has a dropdown list opens, the name of the item (for example, a panel or a model) that is first in the list is displayed. You can open the dropdown list and scroll to another item to select it, or you can enter a filter string. As you enter the filter string, the list of items that meet the criteria is dynamically updated. The string is limited to the exact order of the characters in the string, but the filter is not casesensitive and the filter string can be found anywhere in the results. For example, as shown in Figure 2-10 below, entering the string of **elim** in the Panels field limits the display of the Panels dropdown list to only those panels with the **elim** string found somewhere in their names - Elimination_DB_CS1, Noise_Elimination, and IPO_elimination. To have all items displayed again on a dropdown list, you can click the Clear Field icon (the "x") in the Filter field, or you can clear the Filter field (make sure that the field is blank), and then press Enter.

Non-modal popup feature

On some view tabs, after you click a button to initiate an action, a non-modal popup opens. A non-modal popup is an active popup that has focus; however, although the application behind the popup is dimmed, the application remains active.

Figure 2-11: Non-modal popup




Click anywhere other than the non-modal New Analysis Settings popup to close the popup and return to the MaSTR application.

You do not have to interact with a non-modal popup to close it. Instead, you can click anywhere in MaSTR other than on the non-modal popup itself to close the popup and return to MaSTR. For example, in Figure 2-11 above, the New Analysis Settings popup is open and the Analysis Jobs tab is dimmed. You can click anywhere on the Analysis Jobs tab to close the New Analysis Settings popup and return to the Analysis Jobs tab and access the full functionality of MaSTR.

MaSTR Analysis View

If you log in to MaSTR under any mode other than Admin, then the application opens in the Analysis view, which is the default view. The view has a single tab, the Analysis Jobs tab. The tab lists all the jobs that are queued or currently running on the server, or that have finished running on the server, in reverse chronological order, with a default value of 10 jobs per tab page.

- If an analysis job is queued on the server when the Analysis Jobs tab opens, then Queued is displayed in the Stage column for the job.
- If an analysis job is currently running when the Analysis Jobs tab opens, then one of four stages is in the Stage column for the job:
 - Setup Initiating the job.
 - MCMC Carrying out the MCMC calculations. During this stage, the step number and the estimated remaining time is displayed.

To refresh the display on the Analysis Jobs tab at any time, click Reload.

You can do the following on the Analysis Jobs tab:

• Click anywhere for a finished job to open a table that summarizes the job results. Likelihood Ratio (LR) values greater than one are highlighted in green while LR values less than one highlighted are in red. The darker the green shading, the greater the LR value while the darker the red shading, the lesser the LR value.

Two options are also displayed: Download Summary Report and Open. You can click Download Summary report to view the Summary tables for the populations in the mixture and you can click Open to open and view the Likelihood Ratios report. See "Likelihood Ratios report" on page 89.

- Double-click a finished job to open the corresponding Results page and view the results of the job. See "Generating and Downloading an Analysis Report" on page 83.
- Right-click on any job in the list and on the context menu that opens, select the appropriate option:

Option	Description
Open	If the job is finished, then this option opens the Results view for the job, which details the results for the job on six different tabs. When the Results view opens, the Likelihood Ratio tab is the open tab. See "Generating and Downloading an Analysis Report" on page 83.
Delete	If your user account has the correct permissions, then click this option to delete the analysis job from the MaSTR database.

MaSTR Models View


The underlying concept behind MaSTR probabilistic genotyping software is that of a *model*. A model is a set of parameters that govern the Markov Chain Monty Carlo (MCMC) process and specify how the software calculates the expected signal (peak) heights in a sample. You manage models for your MaSTR installation in the MaSTR Models view.



This section discusses models only from an application perspective. For an annotated list of reference documentation about Markov Chain Monty Carlo (MCMC) and the theory behind continuous probabilistic mixture analysis, see Bibliography on page 145.

To open the MaSTR Models view, on the MaSTR title bar, click Models. The view has a single tab, the Models tab. The tab displays the information for the model that is first on the Models dropdown list.

MaSTR comes populated with eight standard models that have been optimized for probabilistic mixture analysis. You can use any of these standard models as-is, or you can edit a model as needed. You can also import external models. See "To edit a model" on page 44 and "To import a model" on page 42.

Preprocessing Steps	Works in conjunction with Sampler Warmup. A quick, simplified MCM process is run before the full process to find reasonable starting points. Enter an even whole number (integer) for the number of iterations in the thousands, for example, 10 for 10,000 iterations.
	As the number is increased, so is the processing time, but this potentially produces more accurate results. (Without the warmup process, the primary MCMC process might not finish because of poor values for some parameters.) To disable this function, clear Sampler Warmup.
	Note: The only unknown variable in this simplified process is the contributor allele section. The ratio is divided evenly among the contributors and the other variables are held at their default starting values.
Apply Stutter	Selected by default. The model applies stutter during calculations of the probability values. Unless your data does not have good stutter estimates, SoftGenetics recommends that you leave Apply Stutter selected.
	Caution: If Apply Stutter is selected, then Stutter must be calculated for the protocol set that the model uses. See "Protocol Sets tab" on page 59.

To import a model

Although you typically add a model directly to the MaSTR database, you also have the option of importing a model. If you import a model, *the file must be in .json format*. After you import a model, it is available immediately for use in MaSTR. Figure 2-18 on page 43 shows an example of a JSON-formatted model file.



The model name must be unique in the MaSTR database.



- 3. Edit the model properties as appropriate. See Table 2-4 on page 39.

- 4. Do one of the following:
 - To save the modified model as-is in the MaSTR database, click Save.

To delete a model

Because the information for a model that is used in an analysis job is saved with the job, you can delete a model without impacting any jobs that were previously run with the model.

- 3. On the Models tab menu, click Delete.

A Delete < Model Name > popup opens, prompting you to confirm the deletion.

Figure 2-20: Delete Model confirmation popup





Panels tab

You work with panels on the Panels tab in the System view. In MaSTR, a *panel* contains information about the loci that were amplified for an STR analysis job, including the marker name, the markers that are present and enabled in the panel, the alleles that are possible in each marker, the marker repeat length, the lower and upper bounds for each marker, and the analytical threshold for each marker. Panels are listed in ascending order by name, and then within the name, by version number, on the Panels dropdown list on the tab. When the System view opens, the Panels tab is the open tab, and the tab displays the information for the panel that is first on the Panels dropdown list. See Figure 2-21 above.

To view the information for a panel

The Panels tab displays the information for the selected panel. The Markers list on the left side of the tab displays all the markers for the selected panel. By default, the first marker in the panel is selected. To the right of the selected marker, the tab displays information about the marker. If a marker is enabled for a panel, then a checkmark is displayed next to the marker. To the right of the Markers list, the tab displays the possible alleles and their sizes for the currently selected marker.

- 3. You can also do the following:
 - To view information about another marker, select it on the Markers list.
 - To view information about another panel, select it on the Panels dropdown list.
 - To view additional information about a selected panel, on the Panels tab menu, click About.

The About popup opens. The popup displays the date and time that the panel was uploaded to the MaSTR database, the date and time that the panel was last modified, and if applicable, any notes that were added for the panel.

To add a new panel



Even if you enable an amelogenin marker, MaSTR automatically disables this type of marker. MaSTR checks for the string "amel" in a marker name, and if it finds this string, then it automatically disables the marker.

c. Enter the name for the marker.



MaSTR automatically replaces any space in a marker name with an underscore. For example, Penta D is automatically renamed to Penta_D.

d. Enter the marker properties.

Property	Description
Repeat Length	Integer value. The length (in number of bp) of the repeat: 2 for a dinucleotide (for example, AC), 3 for a trinucleotide (for example, AAC), 4 for a tetranucletodie (for example, AGAT), and so on.

To work with elimination profiles for a panel

MaSTR uses elimination profiles to calculate Likelihood Ratios against the mixture and reports them if their results exceed set thresholds. You populate the Elimination database by importing the necessary elimination profile files. You can associate elimination profiles with a panel on the Panels tab, you can edit an elimination profile for a panel, and you can delete an elimination profile for a panel.

Profile names must be unique in the Elimination database for the associated panel.



You work with frequencies on the Population Frequencies tab in the System view. In MaSTR, a *frequency* contains population frequencies for alleles in a specific marker. Frequencies are listed alphabetically by author on the Population Frequencies dropdown list on the tab. When the Population Frequencies tab opens, it displays the information for the population frequency that is first on the Population Frequencies dropdown list.



Although Population Frequency is found in the system view, population frequency is independent of both panels and protocol sets. The allele frequencies are used solely for the purpose of calculating the Likelihood Ratio. See "Likelihood Ratios report" on page 89.

The author name and (publication) year must be unique in the MaSTR database and the decimal designator must be a period.

- Tab-delimited listing of marker name, allele name, and population frequency.
- For *each* marker, the first allele must be listed as "N" and instead of frequency, the file must specify the sample number.



Protocol Sets tab

You work with protocol sets on the Protocol Sets tab in the System view. In MaSTR, a *protocol set* (also referred to as a standard operating procedure or SOP) is a lab-specific file serves that two purposes:

- Defines the variables that the lab uses for a specific STR analysis chemistry (the commercial kit used), including instrument, injection time, PCR cycle, and so on. This is the SOP portion of the protocol set.
- Establishes the expected parameters, based on single-source data, for stutter expectations
 and peak height variation when analyzing samples according to this SOP.




At least one protocol set is required per chemistry and SOP combination that a lab uses for STR analysis.

The following files are always associated with a protocol set:


- Panel file Details the information about the markers and alleles that are to be analyzed for a job. A single Panel file is always associated with a protocol set.
- Genotype file Details the true genotypes of the samples that are listed in the Signal file. A genotype file requires multiple profiles in a single file. See Figure 2-32 on page 60.

Figure 2-32: Protocol set file, required genotype information




• Signal file - Details the alleles for specific individuals at the loci that are being tested *and* the signal (peak) height for each allele.





These files are the standard validation and sensitivity files that your lab uses. These files must contain data for a number of individuals with replicates and a known dilution series. For information about the correct file format and information, see "MaSTR Profile Files and Signal Files" on page 27.

6. Optionally, to have MaSTR check an attached Elimination database for a project, under Elimination DB Filters, enter the values for Minimum LR (the minimum Likelihood Ratio) and Maximum Number of Loci with 0.01 LR (Likelihood Ratio markers).

MaSTR flags the profiles in the Elimination database that is attached to the protocol set's associated panel if the profiles exceed the threshold for the Minimum LR *and* have fewer than the Maximum Number of LR markers.



If you do not enter values for the Elimination DB filters, then MaSTR does not check an attached Elimination database for a job.

7. Click Calculate.




Figure 2-38: Stutter Ratio graph

MaSTR calculates the parameters for variance (which accounts for allele drop-out), stutter expectations, and peak height variation that will be used when analyzing samples according to the SOP. After the calculations are complete, the results, Stutter Ratio (for each allele in every marker) and Variance, are graphed and automatically displayed for viewing. See Figure 2-38 and Figure 2-39 on page 65.

8. If you are satisfied with the results, close the graphs, and then click Save to save the protocol; otherwise, continue to edit the protocol set and calculate the results until you are satisfied with the results, and then you can save the protocol. See "To edit a protocol set" on page 66.



At any time after you close the graphs, you can click Results to open and view the graphs again.

 - Revise and/or replace the genotype text file and/or the signal file used to establish the parameters for the protocol set.



You can click the Delete icon that is displayed next to a file to delete the currently loaded file, and then upload a new file, or you can simply select another file to upload and the currently loaded file is automatically replaced.

- To modify the Stutter values, right-click the Stutter table to open a open a context menu with options such as Copy, Paste, and Insert.
- Edit the Minimum LR and/or Maximum Number of Loci with 0.01 LR Elimination DB Filters.
- On the Protocol Sets tab menu, click About to open the About dialog box, and then enter or edit any notes for the protocol set.

4. Click Calculate.

MaSTR calculates the parameters for variance (which accounts for allele drop-out), stutter expectations, and peak height variation that will be used when analyzing samples according to the SOP. After the calculations are complete, the results, Stutter Ratio (for each allele in every marker) and Variance, are graphed and automatically displayed for viewing. See Figure 2-38 and Figure 2-39 on page 65.

5. If you are satisfied with the results, close the graphs, and then click Save to save the modified protocol; otherwise, continue to edit the protocol set and calculate the results (see "To edit a protocol set" on page 66) until you are satisfied with the results, and then click Save.



At any time after you close the graphs, you can click Results to open and view the graphs again.


To delete a protocol set

Because the information for a protocol set that is used in an analysis job is saved with the job, you can delete a protocol set without impacting any jobs that were previously run with the set.

- 1. If you have not done so already, open the Protocol sets tab for the System view. (System > Protocol Sets).
- 2. On the Protocol Set dropdown list, select the protocol set that you are deleting.
- 3. On the Protocol Sets tab menu, click Delete.

A Delete < Protocol Set > popup opens, prompting you to confirm the deletion.

Chapter 3 DNA Analysis in MaSTR

Running a DNA Analysis in MaSTR

To run a forensic DNA analysis in MaSTR, you apply a validated model to casework samples. The three fundamental components that are required for a DNA analysis are a protocol set, a population frequency (allele frequency) table, and a model. The following procedure describes how to run a forensic DNA analysis in MaSTR. You can set up and run an entirely new analysis according to an SOP, you can rerun an existing analysis as-is, or you can copy an existing analysis, and then modify it to create a new analysis, and then run this new analysis.

To run a new DNA analysis in MaSTR

1. Open and log in to MaSTR.



Typically, the mode that you would use to log in to MaSTR for analyzing casework samples is Casework, but if you have any questions about your login credentials, contact your MaSTR system administrator.

The Analysis view is the open view and the Analysis Jobs tab is the open tab.

2. Click New.

The New Analysis popup opens.

3. Select the analysis components - Protocol Sets, Population Frequency, and Model.



If you are a member of Research/Validation, then to quickly test without editing and saving an existing model, you can click Settings to open the Job Settings popup, and then simply override MCMC Settings and/or Analysis Settings for the model, such as changing the number of iterations.

4. Select the Coancestry Adjustment method, and then enter the adjustment value.





Validating a DNA Analysis Model

Before an analyst runs any DNA analysis, the analysis model must be *validated*. Validation of a DNA analysis model ensures that the analysis meets or exceeds minimum analytical quality for a specific and known data set. It is important that you validate your different analysis models by understanding their quality and characteristics before you deploy them to a production environment.



The following procedure assumes that the appropriate protocol set has already been added to the MaSTR database. See "To add a new protocol set" on page 62.

To validate a DNA analysis model

1. Open and log in to MaSTR.





Review the analysis results to determine if the selected model provides the expected results and therefore, the model validation is successful; otherwise, you must iteratively select a different standard model and/or modify the model properties (other than Variables, all properties such as Iterations or Burn In) and run the assay until the expected results are achieved.

For example, if you initially selected a Standard_30k_8chains model and you determine that this model did not provide enough stabilization to interpret the analysis results, then you might select a Standard_60k_8chains model and rerun the analysis. The results of this second analysis run, however, indicate that the Standard_60k_8chains model greatly exceeds the stabilization requirements. Therefore, you would select either the Standard_30k_8chains model or the Standard_60k_8chains model, and then iteratively modify the appropriate model properties (in this example, you might modify the MCMC Iterations value to achieve 45k iterations) to create a new model and run the analysis until the expected results are achieved.

Adding a New DNA Analysis Model

If none of the standard models meet your DNA analysis needs either as-is, or with modification, then you can always develop new DNA analysis models. When you develop a new DNA analysis model, you can modify all the model properties, including Variables. As with any DNA analysis model, after you develop it, you must validate it before you deploy it to a production environment.



The following procedure assumes that the new DNA analysis and appropriate protocol set has already been added to the MaSTR database. See Chapter B, "Building a Custom MCMC Model for Probabilistic Mixture Analysis," on page 121 and "To add a new protocol set" on page 62.



Generating and Downloading an Analysis Report

After an analysis job is completed, **Finished** is displayed in the Stage column on the Analysis Jobs tab for the job, along with the date and time that the job was finished. If you do not intend to review the data, you can simply generate and download the Analysis report. When you generate and download the Analysis report, you can specify the sections that are to be included in the report and the populations for which you are generating the report. The report is downloaded as a PDF.

To generate and download an Analysis report

1. Open and log in to MaSTR.



The mode that you would use to log in to MaSTR for reporting analysis results can be either Casework or Research/Validation, but if you have any questions about your login credentials, contact your MaSTR system administrator.

The Analysis view is the open view and the Analysis Jobs tab is the open tab. See Figure 2-12 on page 36.

2. On the open Analysis Jobs tab, find the analysis for which you are generating the report.



Remember, you can filter the list of displayed jobs. See "Filter feature" on page 33.

3. Right-click the selected job, and on the context menu that opens, click Download Report.

The Analysis Report for <analysis job> popup opens. The popup indicates the name of the analysis for which you are generating and downloading the report. The popup also lists all the sections that can be included in the report and all the populations that can be reported on. By default, all sections and all populations are selected. See Figure 4-1 on page 84.



Figure 4-1 on page 84 shows the report popup for a in-house version of MaSTR. If you are an administrator, then you can customize the report display to show your organization name and/or logo that is displayed on the report popup and the analysis report. 4. Clear the options for the sections and populations that are *not* to be included in the report.



You should download only the report sections that are relevant to your analysis as the size of the downloaded report can increase exponentially the more information that you select.

The report is generated and downloaded. By default the report is named as Results of <analysis name>, and the report is timestamped with the date that the analysis was run. The first page of the report is always the Run Overview. The report options that you selected determine the contents of the remainder of the report. You can save the report in a location of your choosing, and you can change the default name when you save the report.

Figure 4-2: MaSTR Analysis report example





Signal plot

A signal file lists the alleles for specific individuals at the loci that are being tested and the signal (peak) height for each allele. The Signal plot shows the signal height for the alleles as a histogram. Each peak is labeled with the genotypes that have the allele, where K# = Known, A# = Alternate, and R = Reference. The dotted line in the histogram indicates the analytical threshold that was set in the associated panel. Any peaks that fall below the analytical threshold are displayed in red.

Figure 4-4: Signal plot




Likelihood Ratios report

When the Results view first opens for a selected analysis, the Likelihood Ratios tab is the open tab. The tab displays the reported likelihood ratio that was calculated from the weighted genotypes for each marker and the overall value. You must specify two variables to calculate the Likelihood Ratios report for a marker:


- Profile Choose the profile for which to calculate the L/R ratio, either the Reference profile, any Alternate profile, or any detected profile from the Elimination database.
- Population The population for which to calculate the L/R ratio.

If you select LR Plot vs Random for the profile, then the report displays the range for the overall LR for random profiles from each population, which are indicated by circles. The overall LR from any tested profile is shown as a box plot. The plot shows the expected range from randomly generated individuals for the population, with different colors for each population database.

Genotype Results report

The Genotype Results report is a heat map and a table of weighted genotypes for each locus. The report shows the relative probability of different genotype combinations based on how frequently these combinations were accepted during the MCMC process.




Figure 4-7: Genotype Set Results report

Interactive reports (Contributor Ratio, Degradation Variables, and Model Variables)

Up to three different interactive analysis reports are available for a finished analysis: a Contributor Ratio Plots report, a Degradation Variables Plots report, and a Model Variables Plots report. All three interactive reports have the following characteristics in common:

- All three reports display their relevant information in two plot types a trace plot and a
 histogram plot. For example, the (Contributor) Ratio Plots report displays its information
 in the Ratio Trace plot, which shows the plot of all the individual contributor ratio values
 in each trace and the Ratio Histogram plot, which shows a histogram for each individual
 contributor ratio value. See Figure 4-9 on page 93.
- Both plot types (Trace and Histogram) display 1,000 data points that have been evenly sampled from the trace. All the original data is stored in the MaSTR database, and these 1000 data points are used for efficiency when the plots are generated.
- If a plot legend is displayed to the right of a plot, then you can click on a symbol/key in the plot legend to show/hide specific information in the plot. For example, by default, when the Contributor Ratio plots are first generated and displayed, the plots display the ratio information for *every* individual contributor in the mix. To exclude the ratio information for a specific individual contributor in a plot, click the symbol/key for the contributor in the plot's legend. Click the symbol/key again to include the information.

• Both plot types (Trace and Histogram) have a toolbar. If you hold your pointer over any x/y point in a plot, then a toolbar is displayed above the plot and relevant information is displayed for the selected x/y point. For example, as shown in Figure 4-8 below, if you hold your pointer over any Contributor Ratio Trace plot, then a toolbar is displayed above the report and *all* individual contributor ratio values at the selected x/y point are displayed on the report.

Note the following about a plot toolbar and its icons:

- If the plot toolbar is not displayed, then to display it again, hold the pointer (or you might have to click the pointer) in the location that you would expect to see it displayed.
- You can hold the pointer over an icon on the toolbar to open a tooltip that displays the icon name.
- For some plots, you can use the icon functions in conjunction with each other, but you must be aware be aware of the dependencies for some of these features. For example, for a Contributor Ratio plot:
 - You can use the Lasso icon and the Zoom In icon to zoom in on a selected area of a plot.
 - You can turn on Spike Lines in conjunction with the Show Closest Data on Hover feature or the Compare Data on Hover feature, but the selected data feature takes precedence over the Spike Lines feature. (A tooltip shows the data for the nearest x/y point on the plot, not the farthest point x/y point.)

• If you change any of the default values for a plot, such as the zoom level or focus, then to reset the plot to its default display values at any time, click the Reset ... icon.

Ratio Plots report

The (Contributor) Ratio Plots report is a summary of the sampled ratio values for each contributor.

Degradation Variable Plots report

If degradation was considered during the MCMC process when calculating probability values, then the Degradation Variable plots show the values for the degradation variables. The four variable that can be plotted are the following:




Figure 4-11: Model Variable plot

• Model Variable Plots report - The Model Variable plots tab is displayed for the Results view only if the model that was used for the MCMC process contained custom model variables that were sampled. (See Chapter B, "Building a Custom MCMC Model for Probabilistic Mixture Analysis," on page 121.) At the top of the Model Variables tab, you can select the variable for which to generate the plots. You can limit the plots to specific contributors, markers, and/or alleles. For example, in Figure 4-11 below, the plot is for a model variable that has a different value for each contributor and marker, and the results have been filtered to show the results only for D1S1656.

Run Overview report

The Run tab displays the Run Overview report. The Run Overview report summarizes key points about the finished analysis, including the Protocol Set, Panel, Frequency, and Model that were used, the run name and any run comments, the files (Signal, Reference, Known, and/or Alternate) that were analyzed, the number of contributors, and other information.



If you generate and download the Analysis report, then the Run Overview is always the first page of the report and you cannot exclude this information from the report. See Figure 4-2 on page 86.

Appendix A MaSTR Administration

Admin Mode Default User Accounts

The Admin mode is the only mode in MaSTR that provides the access to all the functions that are necessary for administering and maintaining your MaSTR installation, including audit trails, user management, and database management. Two default user accounts that can log in to the Admin mode are provided as part of the MaSTR installation: root and admin.

• root account - The root account provides access not only to the four standard Admin mode functions (Log, Sessions, Users, and Settings) but also to the MaSTR Database functions, including backing up and restoring the MaSTR database. The root account is the *only* admin account with access to the MaSTR database functions. The root account also has the ability to access any APIs. Further, although the root account has access to user management functions, the account itself is not visible in user management, which means that other users cannot edit its permissions or password, or delete the account.

The default username and password for the root account are root and changeThisPassword. As the MaSTR administrator, as soon as it is feasibly possible for you to do so, you should change the password for the root account. When you change this password, make sure to store it in a secure place, as the password is not recoverable.

 admin account - The admin account provides access to the four standard Admin mode functions (Log, Sessions, Users, and Settings). The default username and password for the admin account are Admin and admin. As the MaSTR administrator, as soon as it is feasibly possible for you to do so, you should either change the password for the account, or after you set up accounts for your actual users, at a minimum, change the account password, or delete the account.

Viewing and Downloading the MaSTR Audit Trail

In MaSTR, a *session* is a temporary and interactive information interchange between the MaSTR server computer and a user. MaSTR records the following information for every API request during every MaSTR session that resulted in a change to the information in a MaSTR database:

- Date/timestamp of the request.
- Host name The name of MaSTR server on which the request was made.
- IP address The local IP address of the machine from which the request was made.
- Username and password for the user who made the request.
- Login mode for the user Admin, Research, Casework, Review.
- Session ID The ID for the session during which the request was made.


Collectively, this information is referred to as an *audit trail*. You can view the entire audit trail up and to and including the current day's date and time for a MaSTR installation in the Audit Trail view. You can also download the same audit trail from this tab to a tab-separated values file that, by default, is named MaSTR_Audit_Trail<download date> (for example, MaSTR_Audit_Trail_8_6_2018), and then work with this file independently as appropriate.

To view and download the MaSTR audit trail

- 1. Open and log in to MaSTR under the Admin mode.
- 2. On the MaSTR title bar, click Audit.

The Audit Trail view opens. The view has a single tab, the Audit Trail tab. The tab displays the audit information for every API request during every session for the MaSTR installation that resulted in a change to the information in a MaSTR database. The information is sorted by session date/time in reverse chronological order.





Viewing and Managing Active Sessions

In MaSTR, a *session* is a temporary and interactive information interchange between the MaSTR server computer and a user. You can view all the currently active sessions for all users (admin or user) for a MaSTR installation on the Sessions tab in the Admin view. Optionally, from this tab you can filter the view to limit the display to sessions only for admin users or only for "standard" users, and you can also "kill" an active session for any user. If you "kill" an active session for a user, then the user is immediately logged out of MaSTR. Any work that user has *not* saved is lost; however, none of the user's queued jobs or jobs that were already running on the MaSTR server are affected.

To view and manage active sessions

- 1. Open and log in to MaSTR under the Admin mode.
- 2. On the MaSTR title bar, click Sessions.

The Sessions tab opens. The tab displays all the currently active sessions for all users (admin or user) in reverse chronological order (based on the user login time) for the MaSTR installation.

Figure A-6: Admin view, Active Sessions tab




Managing Groups in MaSTR

Users are the people who log into MaSTR, whether they are adding and reviewing content, or just using MaSTR in a read-only capacity. User management in MaSTR is based on the concept of every user being assigned to a group, where a group is a collection of users who have the same permissions. Four default users, three default groups, and three login modes* are provided with your MaSTR installation. The Admin login mode determines the admin permissions that be assigned to a user on an individual basis (regardless of any groups to which the user belongs), while the Research and Casework login modes determine the databases—Research or Casework—to which a group, and therefore the users in a group, have access. All three default groups—Analyst, Manager, and Researcher—are available for assignment to the Research or Casework login mode.

- Analyst Grants access to all the permissions that are required to run and view jobs; however, does not grant access to the permissions for updating or deleting jobs or the permissions for adding, updating, or deleting the associated job files (panels, frequencies, models, and SOPs).
- Manager Grants access to all permissions in the database (Research and/or Casework)
 for which it is enabled, including User Administrator, which grants permission to the
 Admin UI for adding, editing, and deleting groups and users in MaSTR.
- Researcher With the exception of deleting jobs, grants access to all permissions in the database (Research and/or Casework) for which it is enabled, including User Administrator, which grants permission to the Admin UI for adding, editing, and deleting groups and users in MaSTR.




Figure A-8: User Management view, Users tab




When you add a new user, you must specify the login credentials (username and password) for the user. When you are adding a new user, you have the option of adding miscellaneous properties for the user, for example, Full Name and Title. These miscellaneous properties are displayed for reference purposes only. MaSTR does not use these properties in any way when determining a user's access and permissions.

You can grant the permissions for the user only after you specify the username and password and then save the user. When you save the new user, by default, no Admin permissions are granted, and the Research and Caswork login modes are selected, but no groups are selected for these login modes. If you do not assign the user to any group, then unless you disable the user's access to a database (Research or Casework), the user will still have basic login and viewing permissions as part of the built-in User group.

- 1. Open and log in to MaSTR under the Admin mode.
- 2. On the MaSTR title bar, click User Management.

The User Management view opens. The view has two tabs - the Users tab, which is the open tab, and the Groups tab.


Figure A-13: Add a Property popup




To back up the MaSTR database

When you back up the MaSTR database, it is a full backup. You do not have the option of incremental or partial backups. Creating an appropriate backup schedule should not hamper daily activities for MaSTR database users while ensuring that the backup file holds the most current information. An ideal backup schedule would for the full database would be during the time when the database is the most inactive.

- 1. Open and log in to MaSTR under the Admin mode as root.
- 2. On the MaSTR title bar, click Database.




To restore the MaSTR database

When you restore the database, all active sessions are immediately stopped and any current data is overwritten by the restored data. Restoring a database should not hamper daily activities for your MaSTR database users while ensuring that the backup file holds the most current information possible. You should always restore the MaSTR database only after your users have logged off, and only from a validated archived file. (See "To validate an archived database" on page 116.)

- 1. Open and log in to MaSTR under the Admin mode as root.
- 2. On the MaSTR title bar, click Database.

The Database view opens. The view has three options: Back Up, Validate, and Restore. See Figure A-20 on page 117.

Figure A-20: Database view




3. Click Restore.

The Open dialog box opens.

4. In the Open dialog box, browse to and select the archived file that you are restoring, and then click Open.

After the restoration is complete, the Database view closes, and you are automatically logged out of MaSTR. Customizing the Default Report and View Displays

When MaSTR is first installed, it is installed with default settings for the following:

- The number of jobs that can be carried out consecutively on the MaSTR server. All other
 jobs are queued. By default, the value is set to two.
- The logo and the name of the organization that is displayed on the Analysis Report popup and on the first page of an analysis report. The logo is also displayed on the MaSTR login dialog box. By default, the logo is set to the MaSTR logo and the organization name is set to a placeholder of [Organization Name]. See Figure 4-2 on page 86.
- The Primary color, which is the color for the MaSTR title bar and components such as buttons, toggles, and checkboxes on a View tab.
- The Secondary color, which is the color for the View Indicator line, the Tab Indicator line, the buttons on the MaSTR login dialog box, and other components.

You can customize any of these settings to better reflect your organization or business requirements.

To customize the view display

- 1. Open and log in to MaSTR under the Admin mode.
- 2. On the MaSTR title bar, click Settings.

The Settings view opens. The view has a single tab, the Settings tab. By default, when the tab first opens, Admin is the selected mode.

MaSTR comes pre-populated with eight standard models that SoftGenetics has determined produce the best analysis results with the least amount of data bias. Moreover, if you are a member of Research/Validation, then to quickly test without editing and saving an existing model, you can simply override MCMC Settings and/or Analysis Settings for an existing model, such as changing the number of iterations. As member of Research/Validation, however, if you want to consider additional factors during an analysis, or you want to reconsider a given calculation for your data, then you can build a custom MCMC model for probabilistic mixture analysis. This appendix provides a high-level overview of how MaSTR calculates peak heights and probability calculations, and where a custom model fits into this process. It also details *variables* and *expected peak height* calculations, which are the two required components for building a custom MCMC model for probabilistic mixture analysis. Finally, it details how to define a model variable for a custom MCMC model.

Peak Heights and Probability Calculations from MCMC Results

MaSTR comes pre-populated with eight standard models that SoftGenetics has determined produce the best analysis results with the least amount of data bias. Each of these standard models provides an explanation of how the analysis data is generated starting with the DNA and then ending ultimately with the quantitative data (expected peak heights and probability calculations) that MaSTR produces.

Peak heights

Peak heights in MaSTR are calculated according to the following steps:



All assumptions detailed below are for example purposes only.

- 1. Begin with a suitable mixture of genotypes, with a value of 1 per allele.
 - Assumptions: Contributors are 14,13 and 14,10 with 14=2, 13=1, 10=1 and other alleles in the panel =0.
- 2. Apply a contributor ratio.

Assumptions: 75%:25% and 14 = 1, 13 = 0.75, 10 = 0.25.

- 3. Apply the amount values, where:
 - One overall degradation *amount* multiplied by "A" for each marker. See "Degradation Variable Plots report" on page 93.
 - Calculate 4000 total peak height (2000 per allele) with an "A" value of 0.9 for this marker, which equates to 1800 per allele.
 - 14 = 1800, 13 = 1350, 10 = 450.
- 4. Apply degradation, where the "D" value for each contributor lowers the expected height of larger alleles for the contributor. See "Degradation Variable Plots report" on page 93.
- 5. Optionally, apply any custom addition, subtraction, multiplication, or division of custom models variables as defined in the model. A variable value is added to the Expected Peak Height calculation through either addition, subtraction, multiplication, or division of the value from the calculated pre-stutter signal. See "Defining Model Variables for Custom MCMC Models" on page 127.
- 6. Apply any stutter that is specified in the protocol set. See "Stutter calculation" on page 124.
 - 14 > 13 = 0.1, 13 > 12 = 0.08
 - 14 = 1620, 13 = 1422, 10 = 450.

Stutter calculation

Stutter ratios are calculated as part of the protocol set using single-source data. If stutter is enabled for a protocol set, then for every allele, stutter ratios are used to move some of the expected peak height from an allele to its stutter position. See "Protocol Sets tab" on page 59.

1. Collect stutter ratio values.

For each sample and each marker in the panel, the stutter ratios are measured as follows: the height of the stutter peak at the minus-1 repeat position is divided by the height of the peak from the contributor's alleles.




If the genotype for a contributor is (A-1, A) at a marker, then the A-1 peak is partially due to stutter and partially due to the genotype. As a result, the contributor samples are not used for calculating stutter at the marker.

2. Apply a liner regression.

To estimate the stutter ratio as a function of allele length, a linear regression is applied to the stutter data for each marker. The stutter ratio for any allele, therefore, can be estimated.

Figure B-1: Linear fit of stutter for D13S317. Blue circles show the raw values and a red line shows the fitted equation




Probability Calculations

After MaSTR calculates the expected peak heights, MaSTR then compares these heights to the observed peak heights to calculate a probability. MaSTR calculates the overall probability as the product of the probability of each peak height comparison. Three comparison calculations are possible:

• Expected and Observed: When a peak is both expected and observed, the heights of each are compared and a probability is calculated. The variance (as calculated in the Protocol Set) is an important part of this calculation.

Even with identical conditions, the peak heights for a sample are not identical across multiple runs. The variance is a measurement of how much noise is expected from run to run. After MaSTR calculates the expected peak heights for a sample, the variance is used to judge the relative weight of this peak height prediction. As the peak height increases, a lower log-fold change is expected between the expected peak height and the actual peak height.

• Drop-out: Drop-out occurs when a peak is expected but is not observed. When generating genotypes in MaSTR, an expected Q allele that represents any allele that was not called in the signal data is included. Because no single height was observed, the peak height is integrated over all values from zero to the analytical threshold.



When MaSTR generates potential sets of genotypes, it does not consider drop-out of two alleles in the same genotype as a possibility.

Drop-in: Drop-in occurs when a peak is not expected, but is observed. Models in MaSTR include a drop-in coefficient, Λ, which determines the likelihood of a drop-in peak based on the peak height. Increasing this value means a decreasing the probability of genotype

sets with drop-in alleles and conversely, decreasing this value means increasing the probability genotype sets with drop-in alleles. "1" is typically a good starting value and changes typically are not observed if the value is < 0.1 or > 5.

Defining Model Variables for Custom MCMC Models

As member of Research/Validation, if you want additional factors considered during an analysis, or you want to reconsider a given calculation for the data, then you can build a custom MCMC model for probabilistic mixture analysis. All the standard MCMC models and any custom MCMC model for probabilistic mixture analysis have the following components in common: Name, MCMC Settings, Analysis Settings, and Advanced Settings. (See "MaSTR Models View" on page 38.) For a custom MCMC model, you can also define one or more custom *model variables* as part of the model. A model variable provides a way of better representing the underlying process that generates allele peak height measurements from DNA. Values are randomly selected from a specified distribution and the MCMC process finds an optimal value for each variable. A model variable has the following components for its complete definition:

When you are defining a model variable, you can define it as an *independent* variable or as a *hierarchical* variable. An independent variable has its own distinct input parameters and its value does not rely on the value of another model variable. A hierarchical model variable uses the value for a previously defined model variable as one of its input parameters, which creates hierarchical models. In hierarchical models, shapes are automatically broadcast as needed. For example, an allele variable with a marker prior variable generates a value for each allele using the prior value for the corresponding marker.



Although you can improve the accuracy of a model by adding model variables, there is a trade-off between this accuracy and model complexity (more model variables result in slower run times and more memory usage), so be aware of this as you define your variables.

To define a model variable

- 1. If you have not done so already, open the Models tab for the System view. (System > Models).
- 2. On the Models tab, click New.

All fields on the Models tab are cleared in preparation for adding the new model.

- 3. Name the model and define the common model properties (MCMC Settings, Analysis Settings, and Advanced Settings). See "To view the information for a model" on page 39.
- 4. Under Variables, click Add.

The Edit Variable dialog box opens. You use the options on this dialog box to define the custom model variable. The input values for the variable depend on the selected Distribution value and whether the variable is an independent variable or a hierarchal variable.

5. Define the model variable.



When specifying the input values for a model variable, ideally, to avoid bias in the model, you should make the input values as broad as is realistically possible.

Figure B-3: Independent model variable, Fixed distribution, single input value




Figure B-4: Independent model variable, Distribution other than fixed, multiple input values






In this example: Regardless of the number of markers in the panel, start with a value of "1" for each marker for the prior variable, the Marker_Fixed_1 model variable. For each contributor, sample a value. The value for the prior variable is used as the Input mean value for this second variable, the Contrib-Marker variable. This hierarchical model variable creates a distribution from which to sample for each contributor, but the distribution is different depending on the marker. The final result is one value per contributor per marker. As example, for three contributors and ten markers, the Marker_Fixed_1 model variable has 10 unique values, with one value per marker, and the Contrib-Maker model variable has 30 unique values.

6. Click Save.



Abstract

Probabilistic genotyping (PG) for evaluation of mixtures provides many advantages compared to historical (CPI, binary likelihood ratio) approaches. Fully continuous approaches utilize more of the information from the evidentiary profile such as peak heights, stutter percentages, mixture ratio, and the probability of drop-in/out to provide weighted genotypes from the mixture profile. The weighted genotypes are used to calculate a likelihood ratio that a profile is included, or not included, in the mixture. Mixture profiles are compared to hypothetical profiles created based on these parameters and hypothetical combinations of genotypes present in the sample in order to calculate how probable it is that a given individual contributed to the mixture. Integration over a large number of interrelated parameters is required to calculate relative probabilities but doing so directly is not feasible. Marcov Chain Monte Carlo (MCMC) is a widely used sampling method to approximate such complex integrals with high accuracy. 1,3 Statistically sound, rigorous software tools are essential for forensic interpretation of complex mixtures that often have multiple contributors, low-level DNA of one or more of the contributors, shared alleles, minor contributor alleles in stutter positions to major contributors, and drop-out. Thorough validation of methodologies is required for forensic laboratories. Conclusions of a preliminary evaluation of MaSTR software indicated MaSTR software provides the rigor of a fully continuous probabilistic approach in a straight-forward software program. A full validation was proposed as the results of the preliminary study were concordant with the known mixture contributors. The validation study of Ma STR software provides the forensic community with a detailed report of the capabilities and reliability of this newly available tool to assist the forensic analyst in applying their expertise to evaluate mixture profiles.

The validation study was designed in accordance with the Scientific Working Group on DNA Analysis Methods (SWGDAM) and Organization of Scientific Area Committees (OSAC) guideline s. Purified, de-identified DNA from 40 donors was obtained from the Nebraska Biobank (University of Nebraska Medical Center), quantified using the Quantifiler Human DNA Quantification kit (Thermo Fisher), amplified with PowerPlexTM Fusion (Promega Corporation), and analyzed o n an A BI PRISM® 3130 Genetic Analyzer (Thermo Fisher). Replicates of single source samples were genotyped (GeneMarker HID software). Files were selected to provide a range of allele calls and stutter information. Results of these replicates and their dilutions were imported into MaSTR software to calculate the variance coefficient and stutter ratios required for the protocol data set. The protocol data set provides the software with context of expected peak height variation over the range of potential RFU values and stutter during the evaluation of mixture profiles. Mixtures ranged from simple, two-contributors with major/minor components with few shared alleles to complex four and five-contributor mixtures with a range of mixture ratios and shared alleles. Mixture samples were also diluted to examine low-template effects across the range of contributors.

The study utilized the standard model within the software. This model utilizes peak heights, drop-in/out, degradation, stutter, co-ancestry (NRC I and NRC II) and allele frequencies from USA populations.⁵ Tests included evaluation of mixtures with: 1) a known contributor profile and no person of interest (POI) profile(s), 2) a known contributor profile and POI profile(s), 3) no known and no POI profile(s) to evaluate deconvolution capabilities and 4) contributor and non-contributor samples to evaluate exclusion capabilities. Additional

parameters included use of the elimination database, containing some of the known contributor genotypes, to mimic detection of staff profiles in a mixture in order to evaluate MaSTR's capability to detect contamination. The number of MCMC iterations and chains required increased with complexity of the mixtures. Results were consistent with known contributors and exclusions. Methodology and tabulated results are presented here.

Methods

All human DNA samples used in this study were purchased as de-identified extracts from the Nebraska BioBank, and were used according to the University of Nebraska-Lincoln's Institutional Review Board's (IRB) approved policies for ethical standards and methods for human testing. Sample collection and experimentation commenced only after the IRB review process was completed.

DNA was extracted at the Nebraska BioBank from 40 donor samples using the Qiagen QIAcube and the QIAamp 96 DNA QIAcube HT kit optimized for downstream genomic assays. Addition of proK and AL buffer and incubation at 56°C resulted in lysis of the cells. The samples were added to the spin columns in the Qiacube for washing and elution of DNA. The DNA was washed via a salt wash (AW1) followed by a salt eliminating wash (AW2) then an ethanol wash. DNA eluted from the column via a low ionic elution buffer. The resulting DNA was quantified using the NanoDropTM One microvolume UV-Vis spectrophotometer at the Nebraska BioBank.

In order to further determine the concentration of DNA in each sample after they were delivered, the extracts were quantified using an Applied Biosystems 7500 real-time PCR system and the Applied Biosystems QuantifilerTM Human DNA Quantification Kit according to the manufacturer's recommendations.

Prior to the analysis of mixed samples, a protocol data set was created for the MaSTR software to use in the assessment of stutter peaks and the calculation of a variance factor. Ten samples were chosen that demonstrated the greatest level of allelic variation available. Each sample was amplified using a n initial quantity of 0.5 ng with five replicates. The samples were then diluted 1:2 and 1:4 and amplified again, each with five replicates, yielding a total of 150 analysis samples with 10 distinct genotypes and a broad range of peak heights for the MaSTR software to use.

Mixture samples were created using two, three, four, or five of the single source samples. Two different strategies were used in creating the two and three-person mixtures. After each single source sample was genotyped, an appropriate number of samples (two or three) were selected that showed minimal or maximal allele sharing amongst the available genotypes, in order to test the MaSTR software under these different conditions. Two different two-person mixture combinations were created, one in which the samples shared a total of five alleles amongst five loci (low share) and one in which the samples shared 19 alleles amongst 18 loci (high share). The same process was used for the three-person mixtures, resulting in one combination with 16 alleles shared amongst 15 loci between the three contributors (low share) and a different combination of contributors showing 31 alleles shared amongst 21 loci (high share). The four- and five- person mixtures were created by randomly selecting previously unused samples and combining them without regard to allele sharing. This gave a total of 19 different single source genotypes used to create 6 mixture genotypes, no genotype was used in more than one combination. Two-person mixtures were made in the following ratios: 1:1, 1:2, 1:3, 1:5, and 1:10. Three-person mixtures were made in the following ratios: 1:1:1, 1:1:2, 1:3:5, and 1:2:10. Four-person mixtures were made in the following ratios:

1:1:1:1, 1:2:2:5, and 1:1:3:10. Five-person mixtures were made in the following ratios: 1:1:1:1, 1:2:2:5:10, and 1:1:5:5: 10. The mixture ratio balance for each sample was in the planned mixture. The amount of input DNA for each contributor was then adjusted so that the peak heights in the mixture should correspond to the desired ratio. Test mixture samples were then assembled and run in triplicate to assess if the amount of DNA in the respective amplifications gave acceptable peak height ratios or needed further adjustment. Once the test mixture samples demonstrated peak heights that fit expectations for the desired mixture ratio, those quantities of DNA were used to create the experimental samples. Each mixture sample was also serially diluted 1:2, 1:4, and 1:8 in order to examine the same contributor ratios with and without stochastic amplification effects. Every final mixture/dilution combination sample was run in triplicate.

All samples were amplified using the Promega PowerPlex® Fusion 5C kit following the manufacturer's protocols. The target initial quantity of DNA for amplification was 0.5 ng and was subsequently adjusted according to the requirements of the specific experimental conditions. The amplification reaction final volume was 25 μ L for a ll samples and thermal cycling was performed in an Applied Biosystems GeneAmp PCR System 9700 using maximum ramp speed for 30 cycles. All amplification sets included a positive control (cell line 2800M DNA, included in kit) and a negative control (deionized water used for sample dilutions).

Separation and detection of the PCR products was performed using an Applied Biosystems 3130 Genetic Analyzer with Foundation Data Collection software v3.0, following all manufacture recommended protocols. All injections were performed at 3 kV for 5 seconds. Separation occurred with Applied Biosystems Hi-DiTM formamide in Applied Biosystems POP4 Polymer. Analysis of all the injection products was performed using SoftGenetics GeneMarker HID v2.9.0 software. All of the two-person mixture samples were analyzed with an analytical threshold of 50 rfu, as were the three-person mixtures except for those that were diluted 1:8, which used an analytical threshold of 30 rfu. All the four- and five person mixtures also used a n analytical threshold of 30 rfu. The differing analytical thresholds reflected the prevalence of low level peaks in each condition and the desire to include allele dropout in some of the combinations in order to further challenge the MaSTR software at each mixture ratio.

Models




Figure C-1: Example of model and submitted jobs

Models were consistent with the exception of varying the number of MCMC iterations. Models with increasing numbers of iterations were used to provide information on minimum and optimal number of MCMC iterations for 2, 3, 4 and 5 contributor mixtures.

The jobs submitted included the mixture sample text file and text files of single source genotypes to be evaluated, without specifying any known single source genotypes. These settings we re-selected in order to mimic the most difficult cases where a known contributor swab is not available. The analyses included simple 2-person mixtures with very limited allele sharing, as well as complex 3 - 5-person mixtures. Two-person mixtures with up to 70% allele sharing were used to mimic related individuals in a mixture. The NR C II 4.1 approach for co-ancestry was selected and coefficient was 0.1 Fifteen mixture analyses included non-contributor single source samples to evaluate exclusion capabilities.

Results

Accuracy of inclusion and exclusion: Seventy-seven analyses of 2-5 person mixtures resulted in accurate inclusion and positive likelihood ratio for all tested samples. Fifteen of the analyses included non-contributor samples. All of the non-contributor samples were excluded, having negative likelihood ratio results.






Summary

Experimental data have shown that the MaSTR software gives accurate Likelihood Ratio results when used with 2-, 3-, and 4-person mixtures. The calculated values for each contributor LR fit well with the true identities and mixture ratios of the synthesized samples. All true-exclusion known samples gave negative (un-supporting) LRs for the appropriate unknown "position" in MaSTR.

The "Major" and "Minor" contributors (mixture ratios of at least 3:1) were clearly and accurately distinguishable via their calculated LRs. Mixture contributors that were at or close to a 1:1 ratio were accurately distinguishable in 2-person mixtures with no identified known sample in mixtures with a high degree of allele overlap. In 3- and 4-person mixtures with a high degree of allele overlap, contributors present in near equal amounts with no identified known samples showed LRs accurately supporting both samples being part of the mixture, but were sometimes difficult to tell apart.

Preliminary work shows that using 10,000 MCMC iterations with eight chains works well for 2-person mixtures. 3-person mixtures, especially with minor contributors, worked well using 20,000 MCMC iterations with eight chains and 4+ person mixtures showed the most consistent results running 50,000 MCMC iterations with eight chains. Increasing the number of MCMC iterations gave more consistent LR values across the replicate MaSTR runs, especially with samples containing minor contributors, allele dropout, shared alleles, and close ratio contributor data.

MaSTR software runs using less than 100K total MCMC iterations were resolved within 15 minutes or less, while longer runs (400K) were completed within 45 minutes using a desktop computer (Intel® CoreTM i7-7700 cpu, 3.60 GHz, 4 core, 8 logical processors) with 8 GB RAM operating with Windows 10.

Further interrogation of the data set is planned to evaluate likelihood ratio results and analysis time when known contributor(s) are included in the analysis procedure, as well as peak height variation in replicate samples.

Abstract: The interpretation of DNA evidence can entail analysis of challenging STR typing results. Genotypes inferred from low quality or quantity specimens, or mixed DNA samples originating from multiple contributors, can result in weak or inconclusive match probabilities when a binary interpretation method and necessary thresholds (such as a stochastic threshold) are employed. Probabilistic genotyping approaches, such as fully continuous methods that incorporate empirically determined biological parameter models, enable usage of more of the profile information and reduce subjectivity in interpretation. As a result, software-based probabilistic analyses tend to produce more consistent and more informative results regarding potential contributors to DNA evidence. Studies to assess and internally validate the probabilistic genotyping software STRmix TM for casework usage at the Federal Bureau of Investigation Laboratory were conducted using lab-specific parameters and more than 300 single-source and mixed contributor profiles. Simulated forensic specimens, including constructed mixtures that included DNA from two to five donors across a broad range of template amounts and contributor proportions, were used to

examine the sensitivity and specificity of the system via more than 60,000 tests comparing hundreds of known contributors and non-contributors to the specimens. Conditioned analyses, concurrent interpretation of amplification replicates, and application of an incorrect contributor number were also performed to further investigate software performance and probe the limitations of the system. In addition, the results from manual and probabilistic interpretation of both prepared and evidentiary mixtures were compared. The findings support that STRmix TM is sufficiently robust for implementation in forensic laboratories, offering numerous advantages over historical methods of DNA profile analysis and greater statistical power for the estimation of evidentiary weight, and can be used reliably in human identification testing. With few exceptions, likelihood ratio results reflected intuitively correct estimates of the weight of the genotype possibilities and known contributor genotypes. Abstract: The introduction of probabilistic DNA interpretation systems has made it possible to evaluate many profiles that previously (under a manual interpretation system) were not. These probabilistic systems have been around for a number of years and it is becoming more common that their use within a laboratory has spanned at least one technology change. This may be a change in laboratory hardware, the DNA profiling kit used, or the manner in which the profile is generated. Up until this point, when replicates DNA profiles are generated, that span a technological change, the ability to utilise all the information in all replicates has been

limited or non-existent. In this work we explain and derive the models required to evaluate (what we term) multi-kit analysis problems. We demonstrate the use of the multi-kit feature on a number of scenarios where such an analysis would be desired within a laboratory. Abstract: In response to requests from the forensic community, commercial companies are generating larger, more sensitive, and more discriminating STR multiplexes. These multiplexes are now applied to a wider range of samples including complex multi-person mixtures. In parallel there is an overdue reappraisal of profile interpretation methodology. Aspects of this reappraisal include:

- 1. The need for a quantitative understanding of allele and stutter peak heights and their variability.
- 2. An interest in reassessing the utility of smaller peaks below the often used analytical threshold.
- 3. A need to understand not just the occurrence of peak drop-in but also the height distribution of such peaks, and
- 4. A need to understand the limitations of the multiplex-interpretation strategy pair implemented.

In this work we present a full scheme for validation of a new multiplex that is suitable for

informing modern interpretation practice. We predominantly use GlobalFilerTM as an example multiplex but we suggest that the aspects investigated here are fundamental to introducing any multiplex in the modern interpretation environment.

Analysis and interpretation of mixed forensic stains using DNA STR profiling

Abstract: The use of multiplex PCR and fluorescent dye technology in the automated detection and analysis of short tandem repeat loci provides not only qualitative information about the profile--i.e. which alleles are present--but can also provide quantitative information on the relative intensities of the bands, and is therefore a measure of the amount of amplified DNA. The availability of this quantitative information allows for the interpretation of mixtures in a detailed way which has not been previously possible with many other human identification systems. In this paper we present a simple approach to the resolution and analysis of mixed STR profiles resulting from the testing of mixed biological stains in forensic casework and highlight factors which can affect it. This approach requires a detailed knowledge--gained through a mixture of experiments and validation studies--of the behaviour of each locus within the multiplex systems described. We summarise the available data from previously published experimental work and validation studies to examine the general principles underlying this approach.

Abstract: A method for interpreting autosomal mixed DNA profiles based on continuous modelling of peak heights is described. MCMC is applied with a model for allelic and stutter heights to produce a probability for the data given a specified genotype combination. The theory extends to handle any number of contributors and replicates, although practical implementation limits analyses to four contributors. The probability of the peak data given a genotype combination has proven to be a highly intuitive probability that may be assessed subjectively by experienced caseworkers. Whilst caseworkers will not assess the probabilities per se, they can broadly judge genotypes that fit the observed data well, and those that fit relatively less well. These probabilities are used when calculating a subsequent likelihood ratio. The method has been trialled on a number of mixed DNA profiles constructed from known contributors. The results have been assessed against a binary approach and also compared with the subjective judgement of an analyst.

Abstract: DNA profiling of biological material from scenes of crimes is often complicated because the amount of DNA is limited and the quality of the DNA may be compromised.

Furthermore, the sensitivity of STR typing kits has been continuously improved to detect low level DNA traces. This may lead to (1) partial DNA profiles and (2) detection of additional alleles. There are two key phenomena to consider: allelic or locus 'drop-out', i.e. 'missing' alleles at one or more genetic loci, while 'drop-in' may explain alleles in the DNA profile that are additional to the assumed main contributor(s). The drop-in phenomenon is restricted to 1 or 2 alleles per profile. If multiple alleles are observed at more than two loci then these are considered as alleles from an extra contributor and analysis can proceed as a mixture of two or more contributors. Here, we give recommendations on how to estimate probabilities considering drop-out, Pr(D), and drop-in, Pr(C). For reasons of clarity, we have deliberately restricted the current recommendations considering drop-out and/or drop-in at only one locus. Furthermore, we offer recommendations on how to use Pr(D) and Pr(C) with the likelihood ratio principles that are generally recommended by the International Society of Forensic Genetics (ISFG) as measure of the weight of the evidence in forensic genetics. Examples of calculations are included. An Excel spreadsheet is provided so that scientists and laboratories may explore the models and input their own data.
